

NCCC Minutes

Nov. 1, 2010

The meeting was called to order by Chairperson Lindy Williams at 7:15 pm at Stonebrooks restaurant in Sacramento. Attending were: Lindy Williams, Chairperson (SPHC); Gwen Russell, Vice-Chairperson (NPHC); Bob Lentz, Treasurer (7-CPHC); Ellen deLong, Secretary (CPHA); Janet Radford (NCPHC); and guest Katy Lentz. SJPHC was not represented.

Motion by Janet Radford, 2nd by Gwen Russell, to approve the minutes of the last meeting. Motion passed.

Treasurer report: Bob Lentz reported a balance of \$4,218.66 in the NCCC account. He also presented a profit and loss report and a month by month income and expense report.

Old business: Lindy Williams has not heard back about the facebook account for NCCC. The clubs had no suggestions for changes to the NCCC class list. Gwen Russell recommended to combine the youth classes to 18 and under, due to declining entries. Janet Radford recommended dropping the 2 and 3 year old performance classes and adding a green horse performance class (as per APHA rules.) The reps are to ask their clubs if they approve of these changes. Also, if a sponsor can be found, NCCC will add a adult walk-jog class. Sponsorship is \$250.00. The NCCC banquet will be with CPHA at the Rockville Inn in Rockville on Jan. 29, 2011; cocktails at 6:00 pm and dinner at 7:00pm. New business: Tentative show dates for 2011 are: SPHC: April 22-23; NPHC: May 6-7 and Sept. 17-18; SJPHC: May 13-15 and Sept. 17-18; NCPHC: May 28-29 and July 16-17; CPHA: Sept. 2-3; 7-CPHC: Sept. 4-5.

Gwen Russell would like to explore the feasibility of having a schooling show to benefit NCCC.

Awards will be ordered as soon as some changes to the points are made and they are final.

Election of officers: Nominated were: Chairperson, Lindy Williams; Vice-Chairperson, Gwen Russell; Treasurer, Bob Lentz; Secretary, Ellen deLong. The slate was passed by acclamation.

The meeting dates for 2011 were set as follows: Feb. 7, May 23, Aug. 8, and Nov. 7, 2011. The meetings will be held at Stonebrooks restaurant on Bercut Dr. in Sacramento. The restaurant is off of I-5 and Richards Blvd. The meetings start at 7:00 pm, unless otherwise noted.
