**2011 ENTRY/NOMINATION FORM
SIERRA PAINT HORSE CLUB STALLION SERVICE AUCTION HALTER FUTURITY**

SPHC – SSA HALTER FUTURITY RULES:

1. Foals nominated **MUST** be sired by stallions purchased from the Sierra Paint Horse Club Stallion Service Auction.
2. Foals **MUST** be APHA registered.
3. Purchasers and Stallion Owners are eligible to nominate one (1) foal each to either the colt or filly halter futurity. Stallion and mare owners foals will be designated as of **September 1, 2011** when the first an only payment is due. The payment is \$130.00. Late payments are double.
4. All entries will close ten days after the due date. This means no entries will be accepted after September 10, 2011. No fees will be returned or transferred.
5. Only one (1) foal is eligible from partnerships or syndicated owners of stallions.
6. Copy of the foals registration papers **MUST BE SUBMITTED** with the payment or the foal will not be
7. Mare owners as well as stallion owners **MUST BE** the breeder on their foal's papers (Breeder: owner of mare at time of service) and this information must match the SSA Stallion Contract Buyers information as stated on the 2009 Stallion Contracts.
8. The purse will be 65% of the monies collected from the auction and 100% of the entry fees minus a \$30.00 office fee for each entry.
9. Owners of stallions siring the winning foals will split a total purse of 10% for each class after the entry fees are added.
10. All entries will be shown under all judges. The overall winner will be determined by the highest score under all judges. Ties will be broken by the tie breaker judge. Ties will be broken for awards only. Monies won by tied horses will be combined and split evenly.
11. Pay-off percentages will be as follows:

In the event of the sale of the foal, it is required that the Stallion Service Auction Committee be notified in writing prior to or with 1st nomination payment. If futurity eligibility has been transferred to new owner with the sale.
3. Copy of APHA registration papers **MUST** be submitted with the payment. Failure to provide a copy of the foal's registration papers will be an automatic disqualification.
